

Dear Parents:

Registration for the 2024-2025 school year will begin January 28th. Registration will be taken on a first come, first served basis and will be considered complete when the classes have reached their licensed capacity. If you have friends or family who are interested in the preschool, please invite them to call for a time to visit the preschool for a tour or come to our Open House on January 28th 10-11am.

To begin the registration process for your child, please complete the attached **Application for Enrollment** form and return it to the preschool office. **The registration fee of \$150 (per child) will be due at time of registration.** Payment of this fee is necessary to guarantee your child's placement for fall.

<u>Your registration fee of \$150 is non-refundable for ANY reason</u>. Please be sure you understand this policy before enrolling your child. Your registration fee will be used to pay to purchase needed supplies for the school and for the processing of enrollment paperwork for each child.

Prior to starting school your child must have all of his/her immunizations up to date and must have evidence of a current physical exam. This is a Colorado State requirement. The preschool does not enroll children who have not been immunized. A required Enrollment packet will be given to you in May. Children will NOT be allowed to start school until all the required forms have been fully completed. Plan now to have them completed and returned to the preschool before the deadline of July 31st, 2024.

As you compare Holy Apostles Preschool with other preschool programs, you will find that Holy Apostles is licensed by the Colorado Department of Human Services. In meeting state specifications, all staff members have background checks with the Federal and Colorado Bureaus of Investigation and the Colorado Department of Human Service's Background Investigations Unit. Going above DHS requirements, all Teachers and the Director are highly qualified, Infant/Child CPR certified and Pediatric First Aid trained and meet rigorous educational credentials. Holy Apostles Preschool is accredited by the National Association for the Education of Young Children (NAEYC). Accreditation is voluntary and achieved by only a small percentage of early childhood programs nationally. It assures you of a high quality program well above licensing requirements.

At Holy Apostles, each class is led by a Teacher who is aided by an Assistant. This gives classes an average ratio of one adult to seven children. The ratio enhances our goal to provide individual attention and develop each child's self-esteem. This low adult to child ratio is not present in most early childhood programs. It assures you that your child's individual social, emotional, physical and cognitive needs are being met. Children are also exposed to our faith curriculum in our Catechesis of the Good Shepherd atrium throughout the year.

Regular family involvement is encouraged through the Co-op commitment that families make to help in the classroom. Each family has an opportunity to provide an adult to assist in the classroom periodically. Social events throughout the year provide family members with the opportunity to come together, share ideas, and have fun. These include Family Picnics, Holiday Parties, Christmas Programs, January Open House, and end of the year Graduations. Required parent responsibilities are detailed on the reverse side of this letter.

On the Application for Enrollment form you will find tuition rates and a schedule of classes for fall. Please return this form as soon as possible to have the best choice of your class time. ^{*}Students may start school once they turn 3 up until 12/31/24 if room is available. Families may opt to pay tuition to hold a place for their child who has not turned 3 yet.

Class choice is based on the age of the child upon enrollment.

Families pay \$150 (per child) at the time of registration. All fees are non-refundable.

Financial assistance may be available for **registered families who qualify** – contact the preschool office for information regarding the application processes.
